Minutes REGULAR MEETING OF THE BOARD OF DIRECTORS APRIL 9, 2018

The Lubbock County Water Control and Improvement District No. 1 (LCWCID) Board of Directors met in regular meeting on Tuesday, April 9, 2018, at 9:00 a.m. in the LCWCID Administrative Offices located at 9999 High Meadow Road, Lubbock, Texas. 1. CALL TO ORDER

President Bill Moore called the meeting to order at 9:00 am.

5. LYNN GREGORY WITH CAPROCK LEONBERGERS TO DISCUSS AND CONSIDER AN AGREEMENT THAT SUPPORTS THE FLCS CONDUCTING WATER TRAINING AND CERTIFICATION TESTING AT THE LAKE

Lynn Gregory provided a brief overview of what the Caprock Leonbergers rescue training consist of and why the FLCS group would like to utilize Buffalo Springs Lake.
