A. Discuss and Consider and take action on funding for the sewer plant in Ransom Canyon with Ellena Quintanilla Director Satterwhite made a motion to Discuss and Consider and take action on funding for the sewer plant in Ransom Canyon with Ellena Quintanilla, Director Hildebrandt seconded the motion. Ellena Quintanilla was present to update the BSL Board on the progress of the new sewer plant located at Ransom Canyon that BSL shares 50% usage of. Discussion on the funding plans to be paid monthly to Ransom Canyon. Currently at a 75% capacity, the construction is set to begin mid to late fall of 2021.

Director Satterwhite made a motion to Discuss and Consider and take action for price increase on motorized watercraft, dirt bikes, ATV'S/UTV'S. Director Hildebrandt seconded the motion, President Keisling aye, Director Lewis Nay. Motion passes with a three to one vote. Director Hildebrandt stated he is strongly in favor of the increase in fees due to the amount of activity we have with the use of watercrafts and ATV-UTVs. Director Hildebrandt would like to see these funds allocated to increasing our Police staff to adequately handle the large volume of watercrafts and ATV-UTV activity on our roads, trails and on the water.

Director Satterwhite made a Motion to increase motorized watercraft gate admission to \$20.00, Dirt Bike gate admission to \$15.00, UTV-ATV gate admission to \$20.00, UTV-ATV season passes to \$120.00, add a season pass for non-motorized watercrafts at \$40.00. Director Hildebrandt seconded the motion, President Keisling aye, Director Lewis nay. Motion passes with a three to one vote.
