The Lubbock County Water Control and Improvement District No. 1 (LCWCID) Board of Directors met in Quarterly meeting on THURSDAY, September 16, 2021, at 9:00 a.m. In the Party House located within Buffalo Springs Lake in Lubbock County, at 9999 High Meadow Road, Lubbock, Texas. Notice of the meeting was legally posted in accordance with Government Code, Title 551, Open Meetings

## 1. CALL TO ORDER AND INVOCATION

PRESIDENT KEISLING OPENED THE MEETING AT 9 AM. DIRECTOR HILDEBRANDT GAVE THE INVOCATION.

## **B. RUNNING CLUB**

MOTION TO OPEN DISCUSSION: DIRECTOR SATTERWHITE

SECOND BY: DIRECTOR HILDEBRANDT.

- STEVE GERMAN CAME BEFORE THE BOARD TO DISCUSS THE RATES FOR RUNNING THE RACES. THE EVENT IS ON THE SECOND SATURDAY IN NOVEMBER. THE FEE HAS GONE UP BY \$3000.00 AND IS PROHIBITIVE FOR THE CLUB. THEY WOULD LIKE TO PAY A FLAT FEE OF \$800.00. THE CLUB IS A NON-PROFIT AND THE MONEY IS GONE INTO COST FOR THE RACE. THE GROUP IS A VOLUNTEER BASE. THE BUFFALO WALLOW IS IN NOVEMBER AT BUFFALO AND LAST SIX HOURS. THE CLUB PROVIDES PORT A POTTIES AND CLEANS UP BEFORE THEY LEAVE. THIS EVENT HAS BEEN GOING ON SINCE THE EARLY 70'S.
- DIRECTOR SATTERWHITE WOULD LIKE TO WORK WITH THE RUNNING CLUB ON THIS EVENT. HE STATED THAT IT IS A POSITIVE EVENT FOR THE LAKE AND GOOD WILL. MR. SATTERWHITE WOULD LIKE TO DISCUSS IT AND SEE WHAT THE LAKE COULD DO. DIRECTOR SATTERWHITE SUGGESTED A "CUSTOMER APPRECIATON DAY" ON THE DAY OF THE RACE AND SET THE RATES FOR EVERYONE THAT COMES THROUGH THE LAKE ON THAT DAY \$5 PER PERSON.
- DIRECTOR BOSTWICK WOULD LIKE TO KNOW WHAT THE PERCENT OF SCHOLORSHIPS IS. THE RUNNING CLUB STATED THEY GIVE A SMALL PERCENTAGE BUT THE PURPOSE OF THE RUNNING CLUB IS ABOUT RACING. DIRECTOR BOSTWICK STATED THAT EACH 501C IS A PARTICULAR EVENT FOR WORKING WITH AND EACH NEEDS TO BE INDIVIDUAL BOARD DECISIONS. DIRECTOR BOSTWICK STATED THAT THIS EVENT DOES NOT USE ANY LAKE RESOURCES AND IS IN SUPPORT OF THE MINIMUM CHARGE OF \$800.00.
- DIRECTOR HILDEBRANDT ASK HOW MANY RUNNERS. THE RUNNING CLUB STATED APPROXIMATELY 250 PEOPLE. HE STATED THAT PROTECTING THE GATE REVENUE IS WHAT THE BOARD STRIVES TO DO. DIRECTOR HILDEBRANDT HAS MIXED EMOTIONS ABOUT IT AND DOES NOT KNOW WHERE TO DRAW THE LINE ON WHAT WE DO AND DON'T DO.
- PRESIDENT KEISLING STATED THE BOARD HAD PREVIOUSLY DISCUSSED THIS
  AND THE WATER DISTRICT DOES NOT CHARGE A VENUE FEE. PRESIDENT
  KEISLING ASK ABOUT THE SPECTATORS DO THEY GET IN FREE. PRESIDENT
  KEISLING AGREED WITH GARY SATTERWHITE ABOUT THE CUSTOMER
  APPRECIATION DAY AND IS FAVOR OF A RATE CHANGE FOR EVERYONE THAT
  DAY.

DIRECTOR BOSTWICK MAKE A MOTION FOR CUSTOMER APPRECIATION DAY ON NOVEMBER 13, 2021 AT \$5 PER PERSON GATE ADMISSION. DIRECTOR SATTERWHITE SECONDED THE MOTION. DIRECTOR KEISLING, DIRECTOR

HILDEBRANDT, DIRECTOR BOSTWICK, AND DIRECTOR SATTERWHITE VOTED AYE. THE MOTION PASSED.

## C. BOAT DOCK PROPOSAL

MOTION TO OPEN DISCUSSION: DIRECTOR SATTERWHITE SECOND BY DIRECTOR BOSTWICK.

- BRANDON POWELL STATED THAT BOAT DOCK BY THE VILLAGE IS IN THE
  WATER AND STARTING TO RUST. MR. POWELL WOULD LIKE TO PURCHASE
  MORE THAN ONE LATER, BUT WOULD LIKE TO PURCHASE ONE FOR THE AREA
  BY THE VILLAGE AND WOULD LIKE TO PURCHASE ONE PER YEAR TO REPLACE
  ALL THE DOCKS AROUND THE LAKE. THERE IS A WARRANTY PLUS THE DOCKS
  RISE WITH THE WATER. THERE ARE NO SLIPS. THERE ARE NO CLEATS ON
  THIS PARTICULAR BOAT DOCK. THE DOCKS HAVE AN EIGHT YEAR WARRANTY
  FOR FACTORY DEFECTS.
- DIRECTOR HILDEBRANT DOES NOT LIKE THAT THE DOCKS ARE PLASTIC BECAUSE THEY ARE SLIPPERY WHEN THEY GET WET. HE WOULD LIKE TO SEE CONCRETE PADS ON THE DOCKS.
- DIRECTOR SATTERWHITE STATED THAT IS A NOMINAL COST AND HE WOULD LIKE TO TRY ONE TO SEE HOW IT WORKS OUT.
- DIRECTOR KEISLING STATED THAT HE WOULD LIKE TO HAVE SOME OPTIONS.
   BRANDON POWELL STATED THAT HE ALREADY PROVIDED THE BOARD WITH OPTIONS AT THE PREVIOUS MEETING. MR. KEISLING WOULD LIKE MR.
   POWELL TO CALL LAKE ALAN HENRY TO SEE HOW THE DOCKS HOLD UP.

## D. APPROVAL OF RESOLUTION FOR BODY CAMERA GRANT

MOTION TO OPEN DISCUSSION: DIRECTOR SATTERWHITE SECOND BY DIRECTOR BOSTWICK.

MIKE CYPERT AS AN ACT OF GOOD FAITH IS ASSITING THE WATER DISTRICT WITH THE GRANT PROCESS. THERE IS 25% MATCH. THE TOTAL COST IS \$4500.00 WITH A 25% MATCH.

DIRECTOR BOSTWICK MADE A MOTION TO SUBMIT GRANT AND WORK WITH THE VILLAGE. DIRECTOR SATTERWHITE SECONDED THE MOTION. THE MOTION PASSED.

DIRECTOR BOSTWICK STATED THAT THE WATER DISTRICT WRITE UP A BID FOR A REMODEL. DIRECTOR KEISLING WOULD LIKE TO PUT THIS ON THE NEXT AGENDA WITH SOME BIDS.
